- **JURISDICTION** :- The Court of Malshiras shall have the solve & exclusive Jurisdiction if any matter occurs relating to the purchase order.

DELIVERY:- Delivery should be given at our Cattle Feed Factory site Shankarnagar 41318. Delivery start and schedule as per purchase order.

- **RATES**:- The rates should be quoted including all Govt. Taxes & duties, including for Factory site delivery.
- **PAYMENT**:- **Payment of Raw Materials purchased by the Shivamrut Dudh Sangh will be paid 50% within 30 day's & Remaining 50% after analysis but within 45 day's from the date of receipt of material.**

TERMS & CONDITION :-

- 01) Suppliers will have to supply the materials as per order and as per delivery schedule at our cattle feed factory and in failure of which the supplier will have to bear the burden of rate difference amount of purchase rate as materials purchased from the open market by the Shivamrut Sangh at the time of production held up to non supply. **No intimation in this regard will be given by us, it will be directly debited & claimed from the concerns Suppliers.**
- 02) The Tender Forms should be submitted only after acceptance of all the Terms & condition mentioned in the Tender Forms.
- 03) Rates will be binding up to **29/01/2022**
- 04) Supplier has to be registered as a nominal Member of Shivamrut Dudh Sangh.
- 05) The Tender will be accepted on **29/01/2022** at Shivamrut Sangh at **12.45 P.M.** Tender forms will not be accepted in any case, after **12.45 P.M.**
- 06) In case of partnership Firm, Copy of partnership deed should be attached.
- 07) Rates quoted will be deemed for the guarantee & specification mentioned in the Tender letter only. Purchase order will be issued as per Specifications.
- 08) You will receive the purchase orders & payments directly by Shivamrut Sangh.
- 09) As your Tender Forms is accepted by the Shivamrut Dudh Sangh You will have to accept purchase order from Shivamrut Sangh only.
- 10) Shivamrut Sangh will place orders with you as per your Tender which is accepted by the Shivamrut Sangh & it is your duty to compile strictly to all the Terms & conditions mentioned in the quotation reeling on which your Tender Forms is accepted by the Shivamrut Sangh.
- 11) Your Tender is accepted subject to your receivable of purchase order from the Shivamrut Dudh Sangh. The purchase order will contain all the payments delivery and other Terms & Conditions.
- 12) Along with the purchased order all other conditions mentioned in the quotation are binding on you.
- 13) Supplied materials should not treated with pesticide or insecticide. If found with the same any losses or damages will be recovered from the supplier.
- 14) Deliveries should be made strictly as per the schedule & place mentioned in the purchase order, failing to do so, the Sangh is free to purchase the materials from open market, extra price/expenses will be recovered from you, Without any intimation . The Sangh reserves the Total right to claim in monitory terms to orders not exected, after placement.
- 15) Purchaser reserves the right to reject the materials even before Analysis if the material appears physically unsatisfactory. The detailed Terms & condition for physically rejection, is already informed to you.
- 16) Rebate condition will be as per our specification enclosed herewith.
- 17) **Tender Deposit of Rs. 10,000/- should be in favor of Shivamrut Dudh Utp. Sahakari Sangh Ltd., Vijaynagar-Akluj by D.D. Interest will not be paid on deposit amount. The Tender deposit will be returned against supplier request after 3 Months of non supply of materials. If you not deposited it will be deduct on your payable bill.**
- 18) Tender must be accompanied with samples for the material which are "AS PER SAMPLE "without sample quotation will not be accepted.
- 19) When excess raw material (Apart from order) is delivered by the party & unloading done to his request the payment rate for the Materials, will be as per the last meeting rate or current meeting rate, whichever is lowest and less Rs. 50/- per M.T. will be deducted.

- 20) In case of any dispute arises between Shivamrut Sangh & Supplier than it will be solved to the subject to Malshiras Jurisdiction court or Solapur Co-op. court only.
- 21) The right to accept/reject any of the Tender is reserved by the management without assessing any reason there of the decision of the rebate & payment under following circumstance will be taken by the Chairman of Shivamrut Dudh Sangh and concerned party .
- If the rejected materials is used.
 - When the material is not available in the open Market.
 - If the material other than rejected is not available with our Shivamrut Sangh.

22) The raw material Rice Bran should be accepted in Gunny & plastic bags.

- 23) The party can go for second Test if our Analysis report is not acceptable, Second test request should be made by supplier within 7 days from the receipt of our Analysis report. The sample will be drawn in Presence of the representative of supplier and Sangh representative of Shivamrut Sangh and Vijayratna Sangh.
 * The expenses will borne by the party (Supplier).
 * The Second test report will be binding on all.
 * The sample will be sent to any reputed laboratory by Vijayratna Sangh.
- 24) Rates of material should be as per our specification only.
- 25) It is the supplier's duty to strictly compile with the Terms & conditions mentioned in the purchase order.
- 26) The gunny bags caring the raw material should be not patched & Torn, If found to be so than Shivamrut Sangh reserves the right to deduct the amount from the payment of the degraded gunny bags. The rate of deduction will be Rs. 8/- per bag for D.O.R.B. & Rs. 12/- per bag for all other raw material. Raw material filled in urea bag (plastic) of 50 K.G. will be accepted. If the raw material filled in 50 K.G. bags (coaltar coating). The party will be called to look in to the mater personally.
- 27) The Rice polish for Cattle must have above 14% oil If tested physically and found to have oil less than 14% the sangh reserves the right to reject it on the spot.
- 28) The Tender form will be accepted only if they are filled and agreed as per the Terms & conditions offered by the Shivamrut Sangh.
- 29) Any changes to be made in the Tender Forms once submitted must be made in writing and handed over to the Managing Director before 2.00 P.M. on the opening date of the Tender or else the rates quoted in the Tender previously will be considered as final rates & you will have to abide by those rates only. (If the rates in Tender have been changed it should be signed by the concerned. The changes of rates should be written in words and figures.)
- 30) The material quoted should be without hesitant smell and fungus.
- 31) Good's will not be unloaded on Sunday & other Holiday's.
- 32) Rejected Material will not be used in any case and it should be lifted by concern party within 2 Month's from the date of supply. If not lifted the rejected material within the above time limit, then the Shivamrut Sangh will not be responsible for that Material, If it is damaged due to any reason.
- 33) Supplier should mention his communication mobile number in his Tender. If any supplier will not mention his communication number then the Sangh will purchase the material directly from the open market due to non supply as per delivery schedule or specification and the rate difference will be debited to the supplier's account without any intimation.
- 34) We require all material rates in KG.**
- 35) When there is change in the rates of particular material change must be sent with sign of the prop.


- * Maize, Javari, Bajra, Wheat Grains etc. the below Moisture 10% acceptable.
- * Materials should be as without dust, chemicals, fungus & Toxins & Urea.
- * Kardi and Sunflower Extr. should be in form of cake Extr. Only. Expander Quality will not be accepted. The material supplied should be in 75% cake form and 25% powders form. If more percent of powder is found the material will not be accepted.
- * **CREDIT NOTES** :- Supplier will have to give credit Notes to the Shivamrut Dudh Sangh within one Month from the date of Materials supply. If credit Note not given within the above time limit onwards payment will not be made by the Shivamrut Sangh to the concerned supplier.
